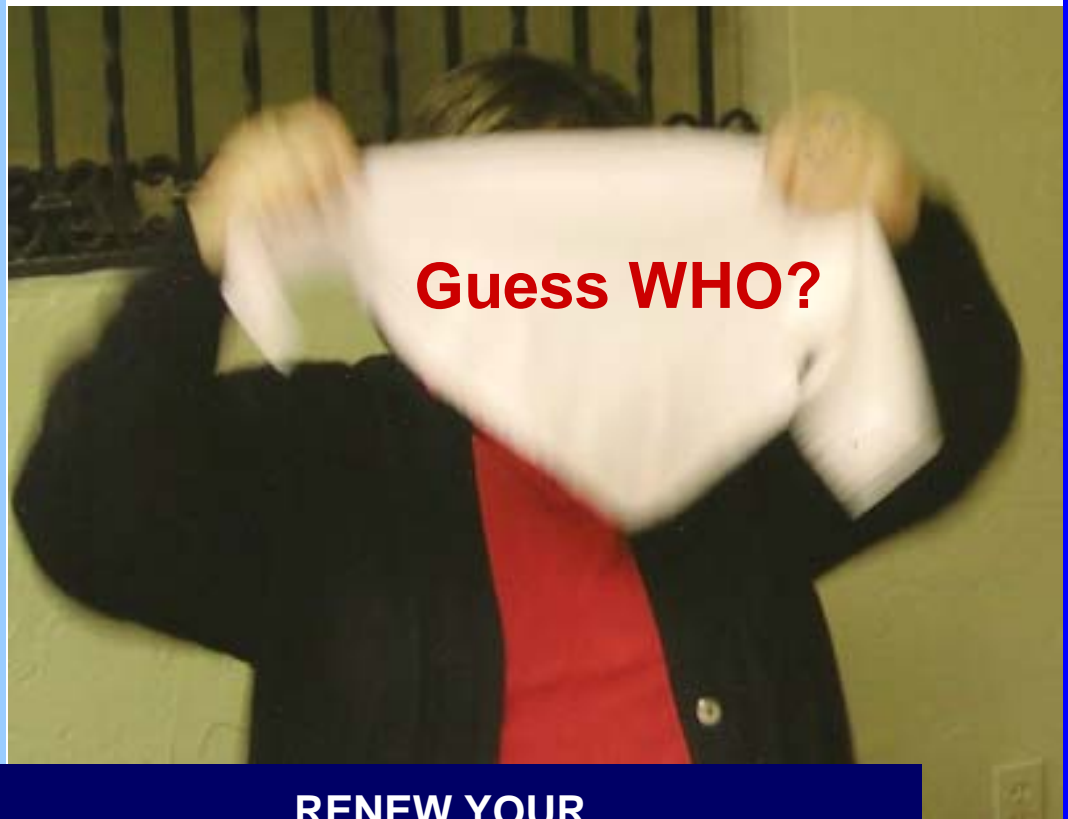

HB3346: allows additional funding for the ISP. For every ticket written, \$15.00 of the fine will go to the Illinois State Police. With this, it will help prevent to lay off of hundreds of State Police Troopers.

Other bills of interest:

HB1383: Medical Marijuana,  
HB3794: Concealed Weapons,  
HB1392, SB1380,  
Abolishing Quotas, HB1936, HB2192:  
Eavesdropping, allowing law enforcement officers to use eavesdropping in situations where officers are working in an undercover capacity and investigating violations of controlled substances and cannabis acts. HB0164, HB0188: would change vehicles to have only one license plate

displayed on vehicles rather than two. For more information on these bills, go to [www.ilga.gov](http://www.ilga.gov).

President Ray Holman called the meeting of the December 6<sup>th</sup>, 2011 Executive Board Meeting to order at 09:30hrs with the Pledge of Allegiance to the Flag and a moment of silence for all of our departed brothers and sisters.

Director Ed Hoes read the roll call of officers. Absent was Chairman John Panzloff of the Fox Valley Division.

A motion was made and seconded to dispense with the reading of the August 2, 2011 Executive Board Meeting. Motion carried.

Attorney's Report: Ed Pacilli stated that he has been working with Director Hoes in the selling of the camp and is looking into the property taxes at the office in getting the assessment lowered. Ed stated that he has received various calls about the pension bills and will continue following the legislation.

A motion was made and seconded to accept the report. Motion carried.

Communications: Director Hoes stated that Nancy, secretary at the office, resigned and that he has a replacement already in place.

Legislation Report: Director Hoes reported that there is not too much to report on pension bills. Several bills involved with law enforcement that did pass were:

HB 1708: which allows law enforcement officers to now be allowed to use silencers, HB2860 passed allowing motorcycles to go through red lights and HB3346, giving the Illinois State Police to receive \$15.00 for each ticket issued helping the State balance their budget and preventing them from laying off several hundred troopers.

Bills that the Association is watching are: HB3794, Concealed weapon, HB1392, SB1380, Abolishing Quotas and HB1936, HB2192, Eavesdropping. If there are any bills that you wish the Association to support or not, contact the Director at the main office.

Motion was made and seconded to accept the report. Motion carried.

Finance & Contracts: Director Hoes read the financial report he received from Mr. Brud Hall of Primerica. There being no questions a motion was made and seconded to accept the report. Motion carried. Ed reported that the computers at the office need upgrading. Ed had a proposal from Scott Thomas a computer programmer for the amount of \$7,000.00. After some discussion, the board asked that the Director get a seconded proposal and report back to the board in April. Motion made and seconded. Passed.

Motion was made and seconded to accept the report as read. Motion carried.

Auditors Report: No report

Conference Report: Ed reported that next year's conference is set for September 21, 22, 2012 at the Crown Plaza, Springfield. Room rates are \$95.00 per night, plus tax for either single or double. Hospitality rooms are \$50.00 per night. More information will be given at the next board meeting.

Death Benefit: Past President Jimmie Rogers reported that 35 claims were presented to the committee. 4 claims were paid at \$400.00 each for a total of \$1,600.00, 27 claims at \$600.00 for \$16,200.00 for a grand total of \$17,800.00. 4 claims were denied for various reasons.

# Cops Corner



## Siren

OK, it's time to read this issue of the Siren. Our members and guests are welcomed to our training programs in the fall and spring during the Illinois Fire and Police Commissioners Association (IFPCA) seminars. In addition to the seminars, IFPCA always presents at the conference of the Illinois Municipal League in the fall. This issue includes some information

about the promotion of physical and emotional wellness among police officers with a look into the future for fire fighters as well.

From our IFPCA website (<http://www.ifpca.info>) "The mission of the Illinois Fire and Police Commissioners Association is to actively encourage the development of fire and police commissioner leaders and to promote a high level of training and ethical standards of excellence in commission leadership and innovation; educate and train the fire and police commission members regarding the practice of hiring, promotion and discipline; and recognize the achievements of the individual members of the fire and police commissions."

You may know that the Illinois Law Enforcement Training and Standards Board, has established the Peace Officer Wellness Evaluation Report (POWER) test for entering any of the Illinois certified police academies. The POWER test is provided to all candidates prior to entering the academy to see if each individual meets the standards. These fitness entrance requirements help to ensure that each recruit can undergo both the physical and academic demands of an academy without undue risk of injury and with a level of fatigue tolerance to meet all academy requirements. If the applicant does not meet all the standards, the recruit will not be allowed to enter the academy.

The POWER test consists of four different assessments:

**1. Sit and Reach Test**

This is a measure of the flexibility of the lower back and upper leg area. It is an important area for performing police tasks involving range of motion and is also important in minimizing lower back problems. The test involves stretching out to touch the toes or beyond with extended arms from the sitting position. The score is in the inches reached on a yard stick.

**2. 1 Minute Sit-Up Test**

This is a measure of the muscular endurance of the abdominal muscles. It is an important area for performing police tasks that may involve the use of force and is also an important area for maintaining good posture and minimizing lower back problems. The score is in the number of bent leg sit-ups performed in one minute.

**3. 1 Repetition Maximum Bench Press**

This is a maximum weight pushed from the bench press position and measures the amount of force the upper body can generate. It is an important area for performing police tasks requiring upper body strength. The score is a ratio of weight pushed divided by body weight.

**4. 1.5 Mile Run**

This is a timed run to measure the heart and vascular system's capability to transport oxygen. It is an important area for performing police tasks involving stamina and endurance and to minimize the risk of cardiovascular problems. The score is in minutes and seconds.

All of the emphasis on physical fitness is fine through the training program at our academies, but once the officers are on the job there may be less emphasis on physical fitness - or just as importantly the emotional wellness of our officers. This feature and perhaps in training brings us to an unprecedented arrangement between the IFPCA and the Police Training Institute in the University of Illinois.

The Police Training Institute (PTI) and the IFPCA have been working collaboratively for nearly 30 years in training commissioners and compiling data regarding the commissioners' training program participation. Recently the two organizations announced that they are supporting an initiative that expands the partnership by investing in the future of those police officers and fire fighters selected by more than 300 boards of fire and police commissioners throughout the state.

The IFPCA Board of Directors recently voted approval of a substantial donation in support of Dr. Angela Wiley and Michael Schlosser's Everyday Wellness Solutions for Law Enforcement Agencies. With the donation, Dr. Wiley and Mr. Schlosser plan to expand the wellness program to fire fighters. According to Dr. Wiley, "by preparing officers to manage emotional and physical wellness at the intersection of professional and family life, municipalities and taxpayers win."

"The program is a testament and an investment in the future for every community in the State of Illinois," according to President Sheila Chalmers.

This past summer, IFPCA President Sheila Chalmers; Commissioner Training Institute Chair, William [Bill] Egan, and Past-president and lead instructor, Janelle Crowley, attended the Police Training Institute graduation to give the check to Executive Director Kris Fitzpatrick. For added value, the three attended Dr. Wiley's program, in support of the expanded partnership.

The IFPCA has long supported communities through training initiatives for community leaders and subsequently, the careful selection of police officers and fire fighters who serve their respective communities. The IFPCA has taken the opportunity to support those community families through a powerful wellness initiative by Dr. Angela Wiley and Michael Schlosser, along with PTI by donating to this initiative. The initiative is intended to be one way a community can mitigate a potential risk, teaching officers how to balance their lives. This program will be a win-win for every participating community in the State of Illinois. By "preparing officers to manage emotional and physical wellness at the intersection of professional and family life," municipalities and taxpayers win, and further supports a creative program developed by Dr. Wiley and Michael Schlosser.

IFPCA and PTI staff will continue to meet and explore whether the program can be expanded. Dr. Wiley and Mr. Schlosser are a "dream team" and have developed a program that can benefit officers, their families, communities, and ultimately, have a positive impact for taxpayers of Illinois. It is a win-win for everyone.

**Death Benefit Report:** Past President Jimmie Rogers reported that there were 120 claims presented to the committee. 14 claims were paid out at \$400.00 for a total of \$5,600. 1 claim for \$572.00 and 86 claims for \$600.00 each. LANGUAGE OF PROPOSED AMENDMENTS TO THE CONSTITUTION AND BY LAWS MAY BE AMENDED AT THE ANNUAL CONFERENCE; PROVIDED THAT (1) THE PROVIDER OF THE PROPOSED CHANGE IS PRESENT IF ANY CLARIFICATION IS NECESSARY AND (2) SUCH LANGUAGE CHANGE DOES NOT SUBSTANTIALLY ALTER THE INTENT OR MEANING OF THE PROPOSED AMENDMENT CHANGE. New section added:

Article 5: Officers and Elections Section 4A Death While in Office: Reads When any duly elected or appointed officer shall die while in office, the President, with the approval of the Executive Board, shall declare his or her office vacant and shall appoint an Active members to such office, subject to the limitations of Article 5 Section 1, to complete the remainder of the decedent's duly elected term of office.

Article 7 Death Benefit Fund, Section 3 Paragraph C: Limitations: Now reads: All claims for benefits must be filed with the Association within (1) one year of the date of death of the member. ANY BENEFICIARY FILING FOR BENEFITS MUST PROVIDE ANY AND ALL DOCUMENTATION REQUESTED BY THE DEATH BENEFIT COMMITTEE WITHIN 6 MONTHS AFTER SAID FILING.

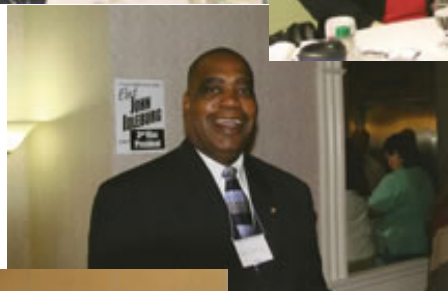
