President Randy Benson called the meeting of the August 7, 2012 Executive Board Meeting to order at 9:30AM, with the Pledge of Allegiance to the Flag and a moment of silence for all of our departed members.

Director Ed Hoes read the roll call of officers. Absent were: Fox Valley Chairman, Keith Chrastka and Mississippi Valley Chairman, John Hassenstab. Excused were Past President Ray Holman, North Shore Division Chairman Jimmie Rogers and Lucky "13" Division Chairman Doug Block. Quorum present.

Attorney's Report: Ed Pacilli reported that he has been working with Director Hoes on the sale of the Sherwood Youth Camp. There is a possible buyer that the Director has been speaking with and more information will be brought up at the annual conference.

Legislative Report: Director Hoes reported on the progress of the bills that the board spoke about at the April Board Meeting. The Executive Board voted on several bills that they wanted the Association to either support oppose or monitor.

There were a large number of bills pertaining to the Public Labor Arbitration Act and Public Relations Act that have all be sent to the rules committee. The Association will continue to monitor these bills. HB4547, 4441, 3339, 3044, 1849, 1673, 1459 and 5931.

The Executive Board made a motion to support the following bills.

HB5635: Mandatory Training for Coroner: This bill has passed both Houses.
HB5098: Mandatory Training for Recruits on Elderly Abuse: Passed both Houses.
HB1392: Prohibits Cities/Municipalities on Ticket Quotas: In Rules Committee.
HB5021: Use of Money from DUI Fund: Passed both Houses.
HB5541: Increase Cost on 911 Service on Cellular Phones: In Rules Committee.
HB5542: Enhance 911 Systems: In Rules Committee.
HB148: Concealed Carry: In Rules Committee.
HB4081: Eavesdropping: Passed both Houses.

The Executive Board voted to either oppose or monitor the following bills.

HB5831: Handgun Registration (Oppose) In Rules Committee.
HB5167: 2% Surcharge on Ammunition (Oppose) In Rules Committee.
Hb0522; Illinois Pension Code (Monitor) In Rules Committee.
HB6122: Allocation of Money from Traffic Surplus Fund (Oppose) In Public Safety Committee.

If there are any bills you feel the Association should support or oppose, please contact me or any board member.

A motion was made and seconded to accept the report as read. Motion carried.

Finance & Contracts Report: Director Hoes read the financial report from Bud Hall of Primerica. Being no questions, a motion was made and seconded to accept the report as given. Motion carried.

Conference Report; the Director reported that the 2012 Conference is set for September 21st and 22nd, 2012 at the Crowne Plaza Hotel, Springfield. Room rates are \$95.00 per night plus tax. Contact person is Darlene Sidwell, (217) 585-2871. Hospitality rooms are \$50.00 per night. Hot plates will be allowed.

Registration fees are \$85.00 per person. (Delegates and Guests) Late registration fees will be \$100.00.

There will be a breakfast Saturday morning, September 22, starting at 8AM for all people attending the conference. The spouses will have their get together at 9AM and will be leaving for the Governor's Mansion at 11:30AM for a tour of the Mansion and luncheon.

Anyone wishing to donate gifts for either the ladies program or the conference please turn them in to me either Friday afternoon or first thing Saturday morning. Please note that the Divisions are NOT required to donate any gifts if they feel their Division can not afford them. This is on a VOLUNTARY basis ONLY.

The banquet doors will open at 6PM with on open bar, (Beer, Wine and Soda Only) for three hours. Mixed drinks will be cash. No drinks will be allowed to be brought into the banquet from the Division hospitality rooms. This is per the hotel. Anyone found bringing in outside drinks will be asked to leave.

A motion was made and seconded to accept the report. Motion carried.

Death Benefit Committee: Vice President Idleburg reported that there were 25 claims presented to the committee All claims were approved and a total was paid in the amount of \$14,172.00. No claims were denied.

Motion was made to accept. Seconded and passed.

Constitution & By-Laws Committee: Director Hoes reported that only one proposed by-law change was submitted to the committee by Past President Ray Holman. Copies of the proposal were handed out to the board members, of which the committee made the recommendation to adopt and that a copy of the proposed by-law change is printed in the "August Official Journal".

Official Journal: Executive Director Hoes reported that the cost of mailing out the "Journal" has increased and that since the cost of the magazine has not been increased for along time he thinks it's time to increase the mailing from \$10.00 per year to \$20.00 per year. A motion was made by Past President Sam Garnati to increase the fee from \$10.00 to \$20.00, seconded by Past President Larry Kearns. Motion passed. Effective January 1st, 2013, anyone wishing to have a copy of the "Official Journal" sent to them by mail, the fee will be \$20.00 per year. (This fee covers all four issues of the magazine for the year.)

Motion was made and seconded to accept the report. Motion carried.

Sherwood Youth Camp Board of Directors Report: Hoes reported that there is a possible buyer for the camp that he has been dealing with for the past several months. Hoes reported that we have a new realtor working with the Association along with Mr. Carl Admire. The new realtor is Illinois Land Company of Washington, Illinois. This group has made a video of the camp and has taken pictures of the camp from the air. Ed reported that he is calling a meeting of the Camp Board of Directors after the Executive Board Meeting today and that a report will be given at the Annual Conference.

Motion made and seconded to accept the report. Motion carried.

Membership Report: Vice President Mike Perry reported that he attended a meeting with the Stickney, Forest View and Oak Park Police Departments handing out applications cards for the IPA. Mike also stated that he has attended two golf

Special Membership: No report.

Public Relations Report: No report.

Shoot Report; Vice President John Idleburg reported that there were shoots on May 16th and on June 20th, 2012. John thanks Chief Jody O'Guinn, the Secretary of the Shoot Committee for all of his hard work and all of the members of the committee. The last shoot of the year is set for September 19th, 2012.

Motion made and seconded to accept the report. Motion carried.

Law Enforcement Memorial Report: The Director read the report submitted to the Board from Memorial Chairman Bob Madura who reported that this year's service was held on May 3, 2012. IPA President Randy Benson gave the invocation at the church services and the ceiling didn't fall in. The attendance this year appeared to be down from the previous years. Bob asks that everyone should attend the memorial and pay their respects for the men and women here in Illinois who have given their lives so that everyone can live safe and sound.

Motion made and seconded to accept the report .Motion carried.

Special Olympics Report: Vice President Chris Surdel reported that he has attended several events including a Dunkin Donuts Cop on a rooftop, 5 Leg torch run in Mokena, blood drives, car shows in Orland Park and Joliet. Anyone wishing to make a donation to the Special Olympics of Illinois should contact Chris.

Motion was made and seconded to accept the report. Motion carried.

Old Business: Ed Hoes reported that the Divisions should be receiving their funds from the new memberships they sent into the main office. The office staff has finally figured out and found all of the membership applications sent in since last year that was not process from the previous office secretary.

New Business: Tri-County Division Chairman Brian Kuratko reported that he was contacted by a Megan Bennett, Executive Director of "Blue For Life, Inc. In 1994 the IPA Board decided to implement the annual scholarship award program. There were two dominant reasons for this decision:

1. To offer a recruitment incentive to prospective new members of the Illinois Police Association.
2. To reward our current members for their continued commitment and support for the organization.

On January 16, 2004, the Scholarship Committee held a meeting and reviewed the guidelines of the program. These guidelines were approved by the IPA Executive Board on April 6, 2004 to administer the program in a more efficient and effective manner for the benefit of our membership.

This information is being published to educate applicants and as a guideline for division officers during their review and processing of all required documentation.

All division chairmen will receive a copy of these guidelines and are expected to follow them to that their applicants receive proper consideration for the award. Any and all questions regarding eligibility should be directed to the corresponding division chairman. The scholarship committee of the Illinois Police Association will ultimately review all submitted applications for compliance and has the final decision regarding the awarding of scholarship funds.

The scholarship committee has worked hard to ensure the success of this ongoing program and asks that the following rules are strictly followed. Thank you for your consideration.

Eligibility:

1. A child (natural or legally adopted), regardless of residency, of an Active or Active Paid Up life member or a stepchild who resides in the same household of the IPA member. The applicant must be under the age of 24 as of November 1 of the corresponding scholarship year.
2. The member must be in good standing with the IPA for least one year prior to the date of application.
3. The scholarship applicant must be a full time student carrying a minimum of 12 credit hours per semester or an equivalent number of hours per quarter In an undergraduate capacity.
4. Full time nursing students who meet the above criteria are eligible to apply.

Persons who are not eligible:

1. IPA members or spouses.
2. Students in a trade, industrial or graduate school.
3. Part time students carrying less than 12 credit hours per semester or an equivalent number of hours per quarter.

Eligibility will be predicated upon each division's roster of Active or Active Paid Up life members as of May 1 of the current year. No transfer of members to a different division will be made within 12 months prior to the deadline for application submissions (November 1 of each year) for the purpose of benefiting in the scholarship award program. Applicants may apply to only one division.

Scholarship Expenditures:

1. The current award will be \$500.00 per school year per student. Each eligible student in a family may apply.
2. Award winners may reapply annually.
3. The Illinois Police Association, Inc. will remit one lump sum payment of \$500.00 to award winner. The payment will be made after the division chairman submits the winning application with all necessary supplementary documentation to the IPA office. All winning applications will then be reviewed and ultimately approved by the scholarship committee.
4. Each of the 13 divisions of the IPA will receive one scholarship annually (if so submitted) at a cost to the association of \$6,500.00

Procedure for Selection:

All applications will be collected and screened by each division for eligibility and the submission of all necessary documentation. After proper verification the division board will prepare the names of all candidates for a random drawing. The winner will be drawn by the chairman at a regular meeting of the division no later than the 30th day of November in the corresponding year. The chairman will also draw the name of the one alternate winner who will not be announced.

Should the announced winner be ineligible for any reason then the alternate be awarded the scholarship and announced at a later date. Divisions should retain all submitted applications in event that the alternate is also found ineligible and yet another winner may have to be selected.

The winning application with all supportive documentation will be forwarded to the IPA office by the division secretary no later than December 15. Pending the receipt of all documentation in a timely manner, announcements of the official winners will be made by the chairman of the scholarship committee at the earliest scheduled board meeting.

If any division fails to submit the name an eligible winner no scholarship will be awarded to said division. Winners of the scholarships will be eligible to reapply the following year.

Verification of Eligibility:

The following must accompany all applications:

1. A copy of the applicant's current class schedule.
2. A copy of an invoice or statement from the bursar's office indicating full or partial tuition payment.
3. A copy or printout of a financial instrument electronic or other document showing full or partial tuition payment.

Important dead lines to remember:

- *November 1 - Application due to division chairman
- *November Division meeting -Random drawing
- *December 15 -Winning application due at IPA office

Cops Corner



Siren

OK, let's pull over now for this issue of the SIREN. We have described many features of the Illinois Fire and Police Commissioners Association (IFPCA), founded many years ago by a few commissioners to develop training programs for commissioners. Each year, about one third of the membership may change in the Boards of Fire and Police Commissioners in municipalities, fire protection districts, civil service boards, and sheriff's departments. The training for the commissioners has remained a mainstay and purpose for the IFPCA. Nearly three hundred municipalities and agencies are members in the IFPCA, and their commissions have the opportunity each seminar to learn what affects their responsibilities to hire, promote and discipline fire fighters and police officers. There were six different instructional modules from IFPCA offered at the fall seminar conducted in Pheasant Run Resort in St. Charles during November 4, 5, and 6. Over one hundred commissioners, chiefs, and recording secretaries attended. There were several commissioners who came early for the golf outing, too.

Module I is what to do about entry level police candidates, how to recruit them, how and where to place ads, establishing the testing vendors and times, the purpose of orientation, the contents of the applications, whether or not to charge for the applications, what needs to be in an ad, whether in newspapers or online, and how to determine what to seek in beginning and police officers. We had a report from one of our member communities how their hiring process worked from advertising to establishing a final eligibility list. Here is what was done: There were advertisements placed in local newspapers, including the Daily Herald (Western Suburbs of Chicago) and the Chicago Defender. There are also a number of agencies which host advertisements to pick up applications. These websites were used: Blue Line, International Association of Chiefs of Police, North East Multi-Regional Training, Inc., and Jobs for Women in Law Enforcement. The police department also has members who attend multiple job fairs and maintains a list of individuals to alert when application packets are available. Fax notifications were also sent to colleges and community colleges in the state which offer law enforcement and related training and degrees.

It is interesting to review the results of this process. For this municipality, there were 790 applications either sent out or picked up. Of those applications, 428 were returned, It is an expense to distribute the forms, and therefore, the municipality and many others typically charge a non-refundable fee of \$10 to \$40 to cover those expenses. Of the 428 that were returned, 426 applicants were invited to the entry level orientation meeting and written examination. The testing was administered by a vendor selected by the board of fire and police commissioners, and a passing score of 80% of the test questions was established.

Only 263 of the applicants invited to the testing attended the orientation and testing session. Part of the application packet included a study guide for the written test, and there were some questions related to the guide on the test. From the 263 taking the test, 73 achieved over 80% correct. All of the examinees were sent a letter indicating their score and whether they passed or failed the test. Those who remained on the applicant list had ten days to provide in writing requests for preference points. Following that deadline and the submitting of requests for preference points, the requests were validated and a final list was established. That list will remain in effect for two years. The disappointing feature during the orientation was that there were currently no vacancies on the department. Some of the applicants did report that they were applying to many different departments in an effort to learn more about testing (just for practice) and because they knew that one department would hire them. We may not know about that but the statements do show their persistence and motivation to become officers. Some applicants had only applied to a couple of departments since they either lived in the town or nearby, and knew which department they wanted for a career.

How do these experiences and numbers compare to the process that you went through to begin your career?

A review and informal survey of commissioners who attended the seminar reported that while their numbers were a little different, the numbers who tested compared with the number who ended up on the final eligibility list was about the same percentage.

One of the benefits of attending the seminars is meeting with and asking other commissioners how they do their work. We learn that while each of us has the same state statutes governing us, we may do the work a little bit differently. We encourage all members of the IFPCA to attend the seminars for training and general updates about legislation affecting our responsibilities.
